To begin with, Republicans stated today that they were only willing to work with Republicans. Amy Solomon and Steve were constantly attacking each other. Also, Jim Clyburn told ProPublica that there was a lot of confusion among the DOJ. Mainly because of the shooting that happened yesterday at a Taco Bell in Texas.
