# Introduction to the committee

The Arab League refers to an alliance with 22 current members on the African continent that have a common mission: to promote peace, security and stability by preventing conflict, resolving disputes and acting in a spirit of solidarity and unity. In doing so, the two organizations work together to expand economic opportunities, promote respect for human rights and foster political inclusion.

# Roles

- Chair
  - The members of the chair are responsible for moderating the functioning of the committee, complying with due protocol, as well as guiding and supporting the delegates throughout the development of the committee. In addition to this, they are also responsible for ensuring the use of parliamentary language and compliance with the rules of procedure stipulated by the handbook within the sessions.
- Crisis center
  - The crisis center aims to make the committee a much more dynamic and lively space, this through press releases when both the center and the board deem it necessary, likewise this is responsible for reviewing and communicating the directives and communiqués submitted by committee delegates, but not before reviewing them and ensuring that they meet the requirements and necessary formats as well as being consistent with the development of the committee.
- Delegates
  - The committee delegates represent a country with respect to the issues being addressed during the debates, have the duty to have a respective investigation, develop the ability to formulate solutions to the issues to be addressed, always keep in mind the parliamentary procedure and always address each other with respect.

# Crisis procedure

#### Directive

- Directives are used to generate actions within the committee, it is important to take into account the objective and repercussions of these, so it is very important that when executing them these are as specific as possible, for this it is recommended to include the why, how, when, who and where of the action. There are two types of directives, public and private.
  - Public directive
    - The actions specified in this type of directive will be known to the entire committee, so it is recommended not to opt for this type of directive if you intend to hide any part of the action to any member of the committee.

## Example of a public directive:

Type of directive: public

Date: 04/30/1886.

Reactors: General Philip Sheridan, Philip Danforth Armour, J.P Morgan, Cornelius Vanderbilt II, Marshall Field, Representative of the Pinkerton Detective Agency, Police Captain William Ward.

Reason/title: Militarization of the most important areas of Chicago.

Goal: Deploy police and military to protect key locations in the city during protests over the next few days.

Actions: With the authorization of General Philip Seridan and Police Captain William Ward, around 550 men will be deployed throughout the city, this to protect the most important places of it, taking into account the revolts proposed by the workers of the different companies in the last days.

The men will be divided as follows:

100 Men (Military) in Lincoln Park (Color Blue).

100 Men (Military) at Lake Park Ave. (Color Red).

50 Men (Police) in the Haymarket area (color Purple).

300 Men (Military) in the Garfield Park area (color orange). These men are able to provide support to the police in the Haymarket area.

The military and police forces are authorized to use all necessary force to eradicate the violent protesters, and have every right to use weapons in defense of their physical integrity.

The 50 men of the police are equipped with the weaponry purchased a few days ago by Mr. Cyrus McMcormic from the Winchester Company.

The movement of the troops will take place at 8:00 am on the day of the protest, they will arrive on foot to each of the established zones.

Resources: 50 police, 500 military. Army weapons already in their possession, and police weapons are those purchased by Cyrus McMcormic.

Role of each member: Police Captain William Ward and Army General Philip Sheridan supply the troops and will send the respective orders to their men.

## **Private Directive**

• They are intended to generate private actions, so that not all committee members need to be aware of this action, however the repercussions of this action will be public. It is important to keep in mind that there are several types of encryption to protect the information within these directives; if a private directive is not encrypted, it can be published by the strategy center.

#### Press release:

• They are used to express a message, opinion or expose events that occurred during the committee by one or more delegations. Generally, these are written in the form of a newspaper article; however, the crisis center will evaluate the possibility of other methods of writing, as long as they are not disruptive to the development of the debate or offensive to any delegate.

## Presidential elections 1994: Ernesto Samper and the so-called narco-politics

Only a few hours after the election results were known, Ernesto Samper being the new President of the Republic, one of his opponent candidates publicly summoned him to a press conference to swear that his campaigns were never financed by drug trafficking. Surprisingly, the now president Samper has agreed to this press conference which will take place in the Casa de Nariño, tomorrow afternoon. This event is called quite controversial considering the various rumors formed around this issue throughout the election process, and it will be of great help for the Colombian people to clarify their doubts about them. In an alleged interview to Andres Pastrana, the candidate behind the proposal, he expresses the following: "I have decided to make this call with the purpose of reassuring all Colombians, and to clarify that the financing of each of our campaigns was totally clean and ordinary".
