Specification of Relevant Roles

a. Crisis center

Is in charge of generating directives that can give delegates context about current situations regarding captures, movements of suspects, and information of use. The crisis center will furthermore be responding to the directives the delegates send to create a more realistic commission in which the actions and plans that are discussed in the committee can have an impact on the course of the events. In addition, the crisis center will be open to teaching and guiding the delegates so that each one of them has an opportunity to learn about directives, portfolios, and other tools that make up the crisis center.

b. Chair

The chair has the wonderful duty of guiding the delegates and moderating the debate and discussion. In the committee INTERPOL the chair will help the delegates with any inquiries the delegates may have and nurture the curiosity, growth, and healthy competition of the delegates to make MMUN XIV a safe and fostering environment for all the participants. The chair, made up of two skillful members of the staff, will make clear to all the delegates what the purpose of the committee is and what is expected of each delegate.

c. Delegates

The delegates are the key pieces to the functioning of every United Nations model. In this specific committee, the delegates will assume the role of being INTERPOL officers, and using skillfully planned directives they will be able to take actions that can benefit the organization and the entire international community. The delegates will have to debate, compromise, plan, and cooperate with each other to allow the commission to function to its full might. It is expected that the delegates act morally, seeking the welfare of all the attendees and always have in mind that collaboration is a key element of the functioning of MMUN XIV.



Objective of the commission

As stipulated in the academic guide, Antonio Anglés is one of the most relevant escape cases in the world. The Interpol committee's goal will be to solve his case with all the tools available to the organization. As a first checkpoint, determining if Anglés is alive is crucial for this mission. If he is, then delegates must proceed to capture him and his accomplices. If he, on the contrary, is found to be dead, Antonio's accomplices are to become the first priority. This has to be done throughout the redacting of investigation directives, and further approval and response from the crisis center.

Crisis Tools and Directives

a. Portfolio power

Is a tool that delegates can use to acquire knowledge or clarify doubts regarding different aspects of the committee. Portfolio powers allow delegates to understand the resources of an entity or understand if an action can be carried out or not. The portfolio power should include questions about the resources or other aspects of the entities the delegates are investigating. The delegates are reminded that the portfolio power is a tool that should only be used when necessary and if the information the delegates are trying to acquire is not available in other sources. It is worth noting that the portfolio powers will be answered as the crisis center deems adequate, so they will not always be answered.

Structure

Date: current date of the committee

Redacting delegation(s): Which delegate(s) are sending the question.

Question(s): The question(s) must be direct and precise.

b. Directives

Directives are tools that delegates can use to take actions inside the committee to have an impact on the commission. The directives can be either public or private, taking into account the purpose and who can have knowledge about the actions taken. These also have to be aligned with what

delegates want to accomplish and the emphasis and the direction the committee has. It is also important to consider the resources of the delegations or institutions so that the actions can be approved by the crisis center. Delegates are reminded that not all the directives sent will be approved by the crisis management.

i. Public directives

These directives are used when the delegates will take concrete actions and the whole committee can be aware of the actions taken. They are also known as press releases, where with a formal register, statements are exposed to the committee as the information is provided to a general public or to a specific group about a particular matter. These directives have to include:

Date: the date on which the directive was drafted

Title of the Directive:

Redacting countries: the name(s) of the delegation(s) that drafted the directive.

Preamble: all directives must have a clear reason and purpose to be approved by the crisis center

Description: must be clear and precise on what action(s) the delegates want to take. It must include:

- A specific place and a date on which the actions will be taken.
- A very clear, step-by-step description of the actions that will be taken.
- A list of resources that the delegates will use and what delegations, governments, or institutions are providing them.
- A list of people involved and what their specific role in the actions will be.

Objective(s): what do the delegates want to accomplish with the actions taken? (Delegates must remember that the effect of the directive will be decided by the crisis center, therefore, the stated objective is not the mandatory outcome)

Signatures: the signatures of all the senders and other parties involved in the drafting of the directive or in the actions that will be carried out.

ii. Private Directives

These directives are used only when the delegate(s) **do not** want their actions to be known by the whole committee. In this sense, the delegates will have to specify the method of encryption they will use. The private directives must include:

Date: the date on which the directive was drafted

Title of the Directive:

Redacting Countries: the name(s) of the delegation(s) that drafted the directive.

Method of encryption: the delegates must consider the date of creation of the method and what other exterior parties have access to the method of encryption. If the delegates fail to encrypt the directive, it automatically becomes a public directive and can be accessed by all the members of the committee. Some encryption methods include Pigpen or Morse code (though that is easily decoded) among many others. Delegates can also create their own to avoid it being decoded; if delegates decide to do this, there will be a need to send a separate, private directive.

Preamble: all directives must have a clear reason and purpose to be approved by the crisis center

Description: must be clear and precise on what action(s) the delegates want to take. It must include:

- A specific place and a date on which the actions will be taken.
- A very clear, step-by-step description of the actions that will be taken.
- A list of resources that the delegates will use and what delegations, governments, or institutions are providing them.
- A list of people involved and what their specific role in the actions will be.

Objective(s): what do the delegates want to accomplish with the actions taken?

Signatures: the signatures of all the senders and other parties involved in the drafting of the directive or in the actions that will be carried out.

The final product of the committee will be a press release.

A press release must include:



- **Date:** a specific date and time in which the article was published
- **Newspaper:** an important newspaper whether it is a local news source or a global one. Our recommendation, as the crisis center, is that you use the BBC as it is the only big news source that is certified by the United Nations.
- **Title:** a pertinent title
- **Description:** It must give a summary of what happened during the committee and what was discussed, in addition, it must include the solutions that the delegates got to at the end.
